Sidi Government of India has launched National Water Mission (NWM) under National Action Plan for Climate

Change and is being guided by Prime Minister's Council on Climate Change. The main objective of NWM is "conservation of water, minimizing wastage and ensuring its more equitable distribution both across and within States through integrated water resources development and management".
