2. BDL has initiated various steps towards water conservation campaign. As part of Jal Shakti Abhiyan, we have constructed Rain water harvesting pit at Ibrahimpatnam Unit and the same was inaugurated by Hon'ble Defense Minister of India. The details of Rain Water harvesting system at various units of BDL is furnished below:

3. At Bhanur Unit we have constructed two check dams across the main nala in plant area to store the run off rain water of open land and allow it to percolate in our land.


