Government of India has launched National Water Mission (NWM) under National Action Plan for Climate Change guided by Hon'ble Prime Minister's Council. The main objective of NWM is "conservation of water, minimizing wastage and ensuring its more equitable distribution both across and within States through Integrated water resources development and management".
