Government of India has launched National Water Mission (NWM) under National Action Plan for Climate Change. The main objective of NWM is "conservation of water, minimizing wastage and ensuring its more equitable distribution both across and within States through integrated water resources development and management". Under the mission every State and Union Territory is being supported to formulate a State Specific Action Plan (SSAP) on Water for sustainable development and management of their water resources by linking with the respective State Action Plan for Climate Change and other sectoral plans. The SSAP includes preparation of State Water Budget.

The State Specific Action Plan on water is a multi-disciplinary activity requiring active participation of all Government Departments related to water from supply side, demand side, governance side, technology side and environment and climate change perspective and also that of non-government agencies and citizens.
